I, the undersigned, acknowledge and agree that my participation in this event is voluntary, at my own risk, and at my own discretion. I understand and accept that participation in an obstacle race, ninja disciplines, and similar sporting activities is physically and mentally demanding and may involve a serious risk of injury to health, property, and other serious consequences.

I understand and accept that participation in the event includes, in particular, the risk of falling, slipping, impact, collision with an obstacle, surface, or another person, loss of balance, bruises, abrasions, cuts, sprains, strains or tears of muscles and ligaments, dislocations, fractures, injuries to the head, spine, and limbs, drowning or inhalation of water, heat stress, dehydration, hypothermia, exhaustion, disorientation, psychological stress, injuries caused by weather conditions, terrain, the technical condition of obstacles, equipment, insects, or animals, as well as other serious consequences, including permanent injury, paralysis, or death.

I understand and accept that even with the organizer's maximum effort, technical measures, course inspection, supervision, and overall organization, it is not possible to eliminate all risks associated with this type of event, and that some risks are inherent in the nature of the event. I further understand and accept that obstacles, structures, hanging elements, landing zones, natural and artificial surfaces, and other parts of the course may, due to weather conditions, wear and tear, prior use, or other circumstances, be slippery, unstable, movable, loose, or otherwise dangerous.

I confirm that I have familiarized myself with the event rules, safety instructions, and the instructions of the organizer, judges, medical staff, and other authorized persons, that I understand them, and that I agree to comply with them without exception. I understand and accept that if I violate the rules or instructions, I may be disqualified from the race without compensation or may be prohibited from entering a specific obstacle or part of the course.

I agree to act with due caution during my participation, not to continue if I consider my health condition, abilities, or any specific obstacle to be dangerous, and to immediately notify the organizer of any defect, unusual risk, or dangerous condition of the course or obstacle that I discover. I understand and accept that the organizer is not responsible for reckless, risky, rule-breaking, or otherwise unreasonable conduct of a participant, for overestimating one's abilities, or for acting contrary to the organizer's instructions, and I agree not to endanger myself or others by my conduct.

I represent that I am medically fit to participate, that I am not aware of any health condition that would make my participation dangerous for me or for others, and that if I have any doubts regarding my health condition, I bear full responsibility for my decision to participate in the event. I further acknowledge that I understand the seriousness of the possible consequences of violating the rules, the organizer's instructions, or overestimating my own strength and abilities.

I expressly consent to first aid, the calling of emergency medical services, treatment, transport, and hospitalization if deemed necessary in view of my health condition, and I consent to the disclosure of necessary information regarding my health condition to persons providing me with medical care or ensuring rescue operations and the safety of the event.

I understand and accept that the organizer may, at its discretion, change the course, obstacles, schedule, rules for passing obstacles, the safety regime, or may interrupt or cancel the event, in particular for reasons of safety, weather, force majeure, decisions of public authorities, the technical condition of the course, or other serious circumstances. I further understand and accept that the entry fee is non-refundable in cases set out in the event rules, in particular if the program is changed or the event is interrupted or cancelled for safety, technical, climatic, operational, or other serious reasons.

I acknowledge and accept that I am solely responsible for my own actions, decisions, and manner of overcoming obstacles. I am liable for any injury or damage caused by my breach of the event rules, the organizer's instructions, or generally binding legal regulations, and I agree to compensate such injury or damage in full.

I further acknowledge that I have been clearly informed in advance of the nature of the event, its obvious and foreseeable risks, and the need for increased caution. To the fullest extent permitted by applicable law, I knowingly and voluntarily assume the ordinary and inherent risks associated with participation in this type of sporting event and agree that I will not assert claims against the organizer, its statutory

bodies, employees, contractors, collaborators, judges, volunteers, partners, sponsors, or any other persons involved in the organization of the event for claims arising solely from such ordinary and inherent risks that I knowingly and voluntarily undertake.

Nothing in this document excludes or limits liability to the extent that such liability cannot be validly excluded or limited under applicable law.

I acknowledge that the organizer, as the controller of personal data, processes my personal data to the extent necessary for participant registration, organization and safe operation of the event, verification of participant identity, maintaining results, handling injuries, incidents, complaints, insurance matters, or legal matters, compliance with the organizer's legal obligations, and protection of the organizer's legitimate interests, in particular in proving the course of the event, the safety measures taken, resolving damage claims, and protecting its rights. I understand and accept that my personal data may, to the extent necessary, be provided to persons involved in organizing the event, timekeeping, medical support, technical operation, IT support, insurance, legal services, or the exercise of rights and obligations related to the organization of the event, and that such data may be retained for the period necessary to fulfill the above purposes and protect the organizer's rights.

I expressly consent to the fact that the organizer or persons authorized by it may, in connection with the event, create and further use my likeness and visual, audio, audiovisual, and similar recordings, in particular photographs, video recordings, footage from fixed cameras, mobile devices, action cameras, and drones. I agree that such recordings may be used in particular for documentation, archiving, presentation, journalistic, promotional, marketing, and commercial purposes of the organizer and the event partners, especially on websites, social media, in printed materials, advertising and presentation materials, and other communication channels.

I also expressly consent to the fact that such recordings may be stored, sorted, searched, tagged, matched, and otherwise processed using automated tools, including tools using artificial intelligence, and that they may be edited in the usual manner, in particular by cropping, cutting, format conversion, combining with graphics, subtitles, music, commentary, partner logos, or other recordings, provided that this does not disproportionately interfere with my dignity or legitimate interests. I acknowledge and accept that this consent is granted without any entitlement to remuneration.

I declare that I have read this document before signing it, that I understand its contents, consider it definite, comprehensible, and binding, that I have been given sufficient time to review it, and that I sign it freely, seriously, and without any duress. I further confirm that the information provided in this document is true and complete.
